- I. Welcome and Established Quorum – Daniela Dulger
Daniela Dulger called the meeting to order at 5:00 pm. She welcomed all in attendance and established a quorum.

- III. Counseling Corner
The counselors are in the process of meeting individually with all seniors to review graduation requirements, post high school plans, and college application deadlines.

We ordered more tests this year than in previous years due to increased interest last year. At this point, the exam has been offered to juniors only. However, if there are still tests available early next week we will allow Sophomores to register.

Utah College Application Week will be held October 21st – 25th. We have representatives from 7 Utah colleges coming to assist students with applications. We're also accepting donations from local businesses as prizes for various games, if you have any business connections please send them our way.

FAFSA Night will be held Tuesday, October 29th, in the Student Center Computer Lab. Professionals will be available to assist families with FAFSA completion. Counselors are encouraging all students to complete the FAFSA as it is required for many scholarships, including the Regents' Scholarship.

Bruce also explained to the SCC members that the TSSA Funds budget was \$240,000.00. The members of the SCC had some oversight but not as much oversight for CSIP and LAND Trust plan. The TSSA funds will be used to focus on lowering class sizes, paying staff taking extra periods.

National Digital Citizenship week is in February which is late for our district. Maria also handed several handouts to the SCC members. The handouts introduced the Digital Citizenship Plan for 2019 – 2020, gave the CCHS Technology Report, a Staying Connected Outline, and a Parents information flyer (Copies are included in the minutes).
