I. Welcome – Jennifer Kalm

Jennifer called the meeting to order at 5:02 pm and established a quorum . she welcomed all in attendance and thanked the members for attending.

II. Review and Approval of October 2021 minutes – Jennifer Kalm

Jennifer asked if all members had a change to read over the minutes. One correction was made to the minutes.

III. Counseling Corner – Misty Jolley

- The Student Center had a very successful Utah College Application Week (UCAW). Almost every senior applied for a least 1 college of their choice.
- FAFSA night will be held Tuesday, November 9, 2021, in the Atrium between 6:00 pm – 8:00 pm. This is a night where parents and students may find out about financial assistance for college.
- This month the counselors will be holding Junior CCR's. The counselors will be meeting with each Junior student and their parent/s. The parent/s may sign up on-line for an appointment. The counselors will go over graduation requirements and answer any questions parents may have about post graduation needs for their student. If the student is planning on college attendance the counselors may help them with scholarship information.

IV. Teacher and Student Success Plan (TSSP) and School LAND Trust Program – Ken Rowley

Ken Rowley said he was following the TSSP and School LAND Trust Plan and that there was no new information to discuss.

V. Review of Bylaws from committee meeting – Jeff Colemere

The committee met to discuss the current SCC Bylaws. The committee members were Misty Jolley, Jeff Colemere, Kim Colton, Jennifer Kalm, and Darrell Jensen. The committee met to discuss changes which needed to be made to the current bylaws. A handout was given to the SCC members with changes marked in red. - CCHS Volleyball Team is competing in the State Tournament.
- CCHS Football Team will be in the quarter finals tomorrow. If they win this game the football team will be playing up at the U of U for the semifinals.
- “Chargers for Charity” is gearing up. The faculty had a soup day which the students and advisors made ceramic and wood bowls for the soup to be served in. Also other wood products, and jewelry items were made for a silent auction. It was a great success. Students will also be out and about the neighborhoods asking to do odd jobs for a donation for Chargers for Charity. There will be many activities in support of the charity. The charity this year is Primary Children’s Hospital. A parent asked what the goal was for this year. Jana White explained to the SCC members that an end goal is not set, many intermediate goal are set with rewards at each level. The students do better when there is not an end goal.
- LIA (Latino’s in Action) students asked if they could have a Light Parade. Mr. Jensen agreed and LIA did the leg work. It was a great success. Many athletic teams, and clubs were involved in the parade. There were about 400 hundred students involved. Hot dogs were cooked and enjoyed by all. A review of the event was discussed and it was decided that the Light Parade would be held during Homecoming Week which would add to the support of Homecoming events.
- The School Musical – Newsies will be held November 11-15, 2021. The cast members total 200 students.
- The mountain biking team competed in St. George for State. There were approximately 6300 bike riders. Mr. Jensen went to St. George and was amazed at the camaraderie of the various team members. It was not just the individual team members, but all bikers competing. Corner Canyon Mountain Biking Team took state. Whitney Pogue has been the coach for the last 10 years and she retired this year.
