V. School Info – Darrell Jensen

Mr. Jensen informed the SCC Members of happenings in the school:

- Arena Scheduling opened today at 3:00 pm and will close January 9<sup>th</sup> at midnight.
- Mr. Jensen wanted to thank Jana White, Case Spaulding, and Shayla Sego, for all their work during charity month. There was over \$86,000.00 raised for Primary Children's Hospital this year.
- Teacher of the year applications are on the district web site and are due by February 4, 2022. The school will send out a skylert to all families who have students attending CCHS to inform them of the Teacher of the Year time line.
- CCHS will be having an evacuation drill on January 21, 2022 during 8<sup>th</sup> period.
- Charger Fair will be held February 2, 2022, 5:00 pm thru 7:00 pm. Charger Fair is 9<sup>th</sup> grade orientation. School Clubs and organizations will have displays to inform 9<sup>th</sup> grade students and parents of classes and clubs the students may choose to attend or be a part of. The counselors will visit Draper Park Middle School later in the month to help students with their schedules. This process also helps with course selections.
- Tonight, the PTSA is sponsoring the Battle of the Bands in the auditorium, Swim Team has a meet, Wrestling has a meet tonight at CCHS, and girls basketball is also playing at CCHS.
- CCHS has 23 cases of Covid-19 as of today. Test to stay will take affect at 48 students.

VI. Other Items

A parent asked if students receive PST credit for being on a sports team at school. Mr. Jensen explained that a student who was playing on a sports team would receive .5 credit which is the credit needed for PST. Also, if a student is a member of another sports team they may receive another .5 credit towards their 1.5 credits of PE needed for graduation.
