

Minutes of the Corner Canyon High School Community Council Meeting held November 7, 2025, in the administrative conference room.

1. Welcome – Andrea Lutz, SCC Chair. Motion was made and seconded to start the SCC meeting. Vote was unanimous in favor of beginning the meeting.
2. Presentation – Dr. Rick Robbins, Superintendent, Canyons Board of Education. Dr. Robbins gave a slide presentation regarding the new Canyons Innovation Center in the former Ebay building.
3. Minutes – Jeff Colemere. Meeting Minutes from October 3, 2024 SCC Meeting were approved as amended. The minutes were amended to indicate that Timette Wankie and Melelina Fiaul were excused absences.
4. Digital Citizenship Plan – Maria Jones via video. Maria Jones presented via previously recorded video the school Digital Citizenship Plan. SCC was also provided with a paper copy of the plan for review and approval. Question was asked about teachers refraining from advocating for political positions while teaching about digital citizenship. Dina Kohler assured the SCC that teachers have been trained as to the teaching guidelines and standards (which prevent political propagandizing of students), and further expressed confidence that Corner Canyon HS teachers will not stray from those teaching guidelines and standards. Motion was made and seconded to approve the Digital Citizenship Plan. Vote was unanimous in favor of approval.
5. School Safety Plan Update – Jordan Denos. Jordan Denos presented an overview and updates to the Safety Plan, which Safety Plan was previously presented to the SCC at the last meeting. Updates included the safety vestibule in the front entry and installation of warning buttons in each classroom that are integrated into the school announcement system. Emphasis is being placed on continuing locked door safety policy, conducting safety drills, and training teachers and staff on safety procedures. Questions about safety when substitutes come to the school were answered—they are given a substitute badge and are briefed on safety procedures prior to class by school admin. Motion was made and seconded to approve the school Safety Plan. Vote was unanimous in favor of approval.
6. Counseling Corner – Michelle Anderson.

Junior CCRs are ongoing. Counselors are meeting one-on-one with Junior Students and their parents to discuss graduation requirements. CREW (Chargers Reaching Excelling Winning) classes were completed by counselors going into classes to discuss goal setting, achieving and dealing with distractions. The counseling office will be starting a scholarship newsletter within the next month. PSAT testing was completed for national merit scholarships. Counselors plan to present a lesson to all health classes on emotional intelligence.

7. PTSA Update – Jen Morris, PTSA President.

Jen Morris requested SCC input as to PTSA fundraising. Ideas were discussed on how to fund the important programs sponsored by PTSA.

8. Review of Current Land Trust Plan – Misty Jolley.

Focus this year is on assisting students who are getting “F” grades. Data was provided on progress. Overall, “F” grades were decreased from last year. Core subjects of Math, Science and Social Studies are all down in “F” grades. English, however, was high in “F” grades. Questions were asked about multiple lingual students at Corner Canyon and how to assist those students.

9. School Information – Dina Kohler.

Brief update on school activities was given by Dina Kohler. Fox13 News highlighted Corner Canyon last week. There was a minor safety incident at the school last week, which was dealt with decisively by school administration. All students were safe. An after-action meeting was held between school administration and Jordan Denos to discuss the situation and what if any improvements can/should be made. Dina reported that high honor roll students at Corner Canyon (3.75 GPA and above) were 1210 of 2440 students for last term. There were also 315 honor roll students (3.5 to 3.74 GPA) last term.

10. Adjourn. Motion was made and seconded to adjourn the meeting. Vote was unanimous in favor of adjournment until January 8, 2025.
